Mark Olson, Ridgefield Park Green Team, was in attendance to discuss the Sustainable Jersey Grant. The Bergen Hub of Green Teams needs a fiscal agent for this grant. Ridgefield Park will be the agent. Styrofoam can be recycled. The BCUA currently does not have the capacity to handle Styrofoam recycling. There will be 12 stations in Bergen County collecting the Styrofoam over the next 18 months and it will be delivered to a company in Springfield. The thought is to create a program that the BCUA would eventually take over.

Ms. Ludmer added the plant is of no benefit to the State of NJ; only added pollution and premature death. They would like to hear both sides before making a decision. Discussions on this matter will continue.
