John Mosca from Donohue, Gironda & Doria was in attendance to discuss the 2014 Audit Findings. There are five recommendations which are not considered severe. The highlight was the increase to the fund balance – surplus now \$2.6 million dollars.

Mr. Mosca stated it is stipulated in the PBA Contract that they are paid on a bi-weekly basis. The PBA would like to remain on a bi-weekly schedule. Therefore, there will be 27 bi-weekly pay periods next year. Employees will see a 3.7% decrease in their paychecks.
