# COMMISSIONERS CAUCUS MEETING RIDGEFIELD PARK April 9, 2015 7:00 PM

Mayor Fosdick announced that this meeting is being held in accordance with the "Open Public Meeting Act, N.J.S.A. 10 4-6 et seq." notice of which was sent to the Record, and the Star Ledger on December 31, 2014 and was posted on the Municipal Bulletin Board.

## APPROVAL OF MINUTES

Motion by Commissioner Boyd, seconded by Commissioner Poli, to approve the minutes of the Caucus Meeting and Closed Session Meeting of March 19, 2015.

On roll call, Commissioners Boyd, MacNeill, Poli and Mayor Fosdick voted "YEA".

## **DISCUSSION I**

John Rolak and Bob Albright, Hatch Mott MacDonald were in attendance. Assemblywoman Marlene Caride and David Grant were in attendance.

Mayor Fosdick summarized the Village's Combined Sewer Overflows (CSOs) issues that the Village is facing to Assemblywoman Caride.

John Rolak stated the Village's Final Permit was issued on March 12, 2015. The Department of Environment Protection had added additional terms in the permit, one being a re-opener clause. He advised once the project is completed and the water quality does not improve, the DEP can re-open the permit. He also advised the language in the permit is overly restrictive. Mr. Rolak advised the Village to submit a Request for Stay and a Request for an Adjudicatory Hearing on the Final Permit to address concerns. Mr. Rolak stated the DEP can reject the Hearing and Stay request.

Asw. Caride inquired about funding for the Village. Mr. Rolak advised that there are no funds available at this point. Funding is up to the municipalities.

At this time, Mr. Rolak and Mr. Albright left the meeting.

Mayor Fosdick advised Asw. Caride that it took the Village 60 years to get the County Park built. One of the provisions in the original agreement with the County was the provision for the County to fund the construction of a pedestrian bridge.

Asw. Caride advised the County did bond for the funds for the bridge. She stated she would set up a meeting with County Executive Tedesco and also draft a bill.

Commissioner Boyd advised that since Challenger Road is a County Road, new signage and paving should be done.

Asw. Caride asked if documentation on the Challenger Road issues be emailed to her.

At this time, Asw. Caride and David Grant left the meeting.

Mayor Fosdick stated CSX will be inviting OEM Coordinators from each town to Atlanta, GA for a 3 day seminar.
