#### APPROVAL OF MINUTES

Motion by Commissioner Poli, seconded by Commissioner MacNeill, to approve the minutes of the Caucus Meeting and Closed Session Meeting of January 8, 2015.

#### **DISCUSSION**

Mayor Fosdick stated the CSO compliance project is a monstrous problem. He informed all, as per John Rolak, the State DEP will not allow Ridgefield Park to work with the Passaic Valley Sewer Authority on the CSO issues since the Village is not part of the Passaic Watershed. The Village should attempt to join forces with Hackensack and Fort Lee. If alone, the final plan will have to be prepared in 3 years instead of 5 years and the Village may not be eligible for aid. The Mayor will draft a letter to Hackensack and Fort Lee. Alan O'Grady stated the GSI mapping should be completed in 6 months. The BCUA is allowing Ridgefield Park to use their base maps. Commissioner Anlian stated a letter should be sent to the DEP asking why the Village cannot link with the Passaic Valley Sewer Authority.
