DISCUSSION

2016 Budget

Commissioner Boyd stated, under the advisement of Bill Betesh, the Tax Appeal line should be increased to \$115,000 – \$120,000.

Commissioner Anlian advised there are corrections that need to be made to a few of his budget accounts.

Mayor Fosdick advised the Library has decreased its budget by \$40,000 on their own. The goal is to keep the tax rate the same or less than last year.

Mr. Buono stated he is confident with the proposed 2016 budget.

Mayor Fosdick stated Congressman Pascrell will be at Hose Co. No. 4 next Tuesday for a presentation by the Fire Department.

Chief Financial Officer Buono advised the annual financial statement reflects there is a lot of grant money remaining in trust funds. He will reach out to Commissioners and Department Heads for assistance with account balances.

Superintendent O'Grady advised the Environmental Commission needs to get involved with the CSO issue as an advisory committee. They will need to attend meetings with Hackensack, Fort Lee, the County and Engineers. Mr. O'Grady stated the DEP has made funds available (interest free) for CSO planning. The Commissioners agreed to have John Rolak apply for these funds. Mayor Fosdick stated the Environmental Commission should join Sustainable NJ.

Attorney Boggia stated he has been in contact with Boswell Engineering regarding the US Soccer Foundation Grant and Hellas Construction. He advised it is more of a discount than a grant. The Soccer Association Representatives should meet with Boswell Engineering to clarify issues.
