Commissioner Boyd advised 100 Challenger Road will receive a \$500,000.00 tax appeal settlement.

Commissioner Poli advised a resident inquired about talking crosswalks at traffic signals. Chief Rose stated the only crosswalk the Village would be responsible for is Main/Cedar Street since the others are County Roads. Chief Rose will inquire with the County. Commissioner Poli advised a budget transfer from DPW to Ambulance Corps. needs to be processed. Mrs. O'Grady advised Commissioner Poli that he is over the bid threshold with the Ambulance Corps. purchase order for Physio-Control Corps. If the bill is brought down just below the bid threshold, Mr. Voytus stated he will need quotes. Commissioner Poli advised medical benefits are increasing 20%.

Commissioner Anlian advised Kerstin Keyser is to be appointed to the Board of Health as an Associate Member of the Shade Tree Commission. He completed his deposition in reference to the lawsuit regarding 19 Grand Avenue. He advised since the Village has a Shade Tree Commissioner with an approved Community Forestry Plan and annually completed education credits, the case will probably be thrown out.
