REPORTS

Commissioner Boyd advised Commissioner Poli that Bank of America will not be reversing the service charges on the Health Benefits account. Also, the Village has approximately 8 accounts in TD Bank under their "Municipal Government" product. In December, they will no longer waive fees on accounts. The Village should open these accounts in Oritani Bank. The meter money account can remain in TD Bank under the direction of the branch manager.

Commissioner Poli inquired about the pool lawsuit. Mr. Boggia advised a letter was sent to vacate the default since the Village Clerk didn't receive the documentation on the lawsuit from the pool secretary in a timely matter. Commissioner Poli stated he had received an e-mail from the State Farm agent complaining about the parking enforcement. He will respond to his complaint.

Commissioner MacNeill stated the Hobart Street Field and High School Track projects are almost completed.

Mayor Fosdick reminded Commissioner Anlian to write a letter regarding St. Francis' Anniversary. The Eagle Scout ceremony is at 3pm this Sunday at St. Francis. The VFW will be closing and are proceeding with donating the property to the Village. The Mayor advised the Village will be responsible for the title search. The Board of Commissioners is invited to the Board of Education Faculty Meeting on September 2nd at 8am at the High School September 7th is a car show at the High School. Police Negotiations are to commence. He advised Commissioners MacNeill and Poli to meet with the police negotiating team, without attorneys, to find out their concerns. On September 23rd, Detective Cmielewski will be promoted to Sergeant. The public swearing in of Ptl. David Marco is also on September 23rd.

Clerk O'Grady inquired if the Village will be having a 9/11 ceremony. Mrs. O'Grady will check with the Fire Department.

Superintendent O'Grady advised the EPA had ordered the Department of Environmental Protection to inspect the Village's netting chambers. The DEP advised Mr. O'Grady the Village is the only CSO community without a consent order against them.

Chief Rose stated the Police Department is scheduled to have a meeting with Jefferson School on security and crossing guards have been hired. The camera project is progressing. The costs just came in for the improvements to the jail cell. The pay stations have been ordered. The Sheriff's Department and County Police have an implementation meeting. Chief Rose also stated that he would like to purchase two defibrillators for the Municipal Building and conduct CPR training for the employees. The cost would be approximately \$850-\$900 each. The Board of Commissioners stated it would be a good idea.
