DISCUSSION

- CSO Ordinance Mr. O'Grady advised the funds appropriated will cover the fees to Passaic Valley, Hatch Mott MacDonald, a new sewer truck, vortex valves, computer software. Ordinance to be introduced on Tuesday, January 26, 2016.
- Soccer Field Ordinance Commissioner Boyd raised questions regarding the cost. Are soft costs included in the estimate? Does the Village pay the entire cost and submit payment for reimbursement? Commissioner MacNeill advised the Soccer Association cannot move forward with the grant without the ordinance. Mayor Fosdick asked to have the Soccer Association present at the next Caucus Meeting. The Ordinance will not be introduced on Tuesday, January 26, 2016.

HEARING OF CITIZENS

REPORTS

Commissioner Boyd advised the 2016 Budget paperwork is due in 1 week. The Village has lost approx. \$6 million in ratables due to tax appeals.

Mayor Fosdick advised the Police Department awards will be Tuesday, January 26, 2016. He stated Bogota's VFW contacted him regarding the Palisade Avenue Bridge. Since, the bridge is entirely in Ridgefield Park; they would like permission to dedicate the bridge. The Mayor stated he attended the County Executive's discussion at MetLife Stadium on economic improvements. He advised there was a school threat from a student at the high school.

Clerk O'Grady stated she and Commissioner Poli met with a representative from New Jersey Manufacturer's Insurance Company (NJM). Anyone who receives a W2 from the Village is eligible for insurance with NJM. They will be on site on February 12, 2016.

DPW Superintendent O'Grady advised he attended the BCUA meeting on Tuesday with all the CSO communities. July 1st is the next deadline – website showing outflows. Passaic Valley has the website and is prepared. The DPW is fully prepared for the forecasted blizzard.

Chief Rose stated the accreditation inspection dates are February 21st and 22nd. The Police Dept. is close to making a conditional offer of employment for the utility officer position. There will be an inspection of the regular jail cell by the DOC.

Village Attorney Voytus advised as per Econsult's report, the prospective need for COAH in the Village is "0". The next step in the process is to designate Econsult as the Village's expert. Municipalities are forming a consortium to depose Econsult. He inquired if the Village would be interested in the shared service agreement.
