Village Clerk Tara O'Grady stated she received a call regarding a clothing bin for recycling purposes located on the sidewalk on Brinkerhoff Street. The Fire Department was granted permission to have these similar bins on private property since Mrs. O'Grady was advised by the Building Department there was currently no ordinance in place stating they were not permitted. DPW Superintendent O'Grady advised, as per the ordinance, exemption applications for recycling go through the Recycling Coordinator. He suggests the ordinance be tightened.

DPW Superintendent Alan O'Grady advised the Board of Commissioners should adopt a resolution authorizing to receive bids for the paving of Euclid Avenue, Christie and Brinkerhoff Streets.
