### **REPORTS**

**Commissioner Boyd** advised as per the Global Credit Report, Ridgefield Park is stable/adequate. TD Bank has sent a proposal for all Village business banking accounts; however; they are still not willing to absorb the payroll fees. The 2013 Best Practices has been completed and the Village's State Aid will remain the same. Commissioner Boyd asked Mrs. O'Grady to issue a memo to all Boards for 2014 meeting dates.

**Commissioner Poli** received a notice from Bergen County VOAD (Voluntary Organizations Active in Disaster). Mrs. O'Grady will post notice on the Municipal Building's bulletin board and forward to Stephen Orovitz to post on the website.

**Commissioner MacNeill** inquired if the meter maid position is close to being filled. Chief Rose responded no. The Commissioners stated the Parking Moratoriam will be from December 1, 2013 through January 4, 2014.

**Mayor Fosdick** advised he is meeting with a prospective police officer tomorrow. There are currently two police officers out on leave. The Public Hearing on the Bond Ordinance and Salary Ordinance will be on Tuesday, October 22, 2013.

**Clerk O'Grady** stated she looked into the guidelines for Sustainable NJ. A resolution would need to be passed stating intent to pursue certification and designate a liaison; register online; mandatory to create a "green team" consisting of staff and citizens.

**Superintendent O'Grady** advised the General Permit meeting is November 13, 2013 from 10am-12pm. Mr. O'Grady stated he forwarded Boswell Engineering bills to Mrs. O'Grady regarding the remediation and testing of Veteran's Park. An account should be established to pay these bills.

**Attorney Boggia** stated he has been contacted by Ron Ladell. He would like to meet with Commissioners Boyd & MacNeill next week to discuss designs. Commissioner MacNeill advised Fred Rosen should be present at the meeting. Mr. Boggia stated the Letter of Credit for \$1.8 million has been sent. Avalon has acquired the special permit for testing on a former landfill.
