DISCUSSION I

Adam Altman, owner of 3 buildings in the Overpeck Park Corporate area was in attendance. He stated that he is very optimistic that the Challenger Road Corporate area can become one of the premiere office destinations in the state, primarily due to the proximity to the Lincoln Tunnel and the George Washington Bridge. He stated the signage for the corporate area, as well as the new Overpeck County Park, is run-down. He would like to see a new signage program to attract visitors to the park. The Mayor and Commissioners were in agreement the signage is terrible. Mr. Altman will provide new signage renderings to the Board of Commissioners for review. Mr. Altman added Avalon Bay was a good choice for the redevelopment project. They are a respective builder and hopes to see retail components in the redevelopment.

Mr. Altman thanked the Mayor and Commissioners for their time and left the meeting.

REPORTS

Commissioner Boyd advised she will not be attendance at the next caucus meeting, August 8th. Commissioner Boyd stated she was glad to receive the financial agreement draft for Avalon Bay.

Commissioner MacNeill advised the Building Department is requesting a dedicated account for emergency repairs. Commissioner Boyd stated the account would need to be set up properly.

Mayor Fosdick advised he is hosting the Rotary Club meeting on August 7th. He stated the Police Department is proposing to upgrade their dispatching, computer system. Captain Hippe will present the proposal. One new police officer will be hired and sworn in next Thursday, August 22nd.

Clerk O'Grady presented a Summer Hours Proposal from the Municipal Building Staff. The staff proposed to work additional hours during the week and in return, close on Fridays. The Commissioners were not receptive and decided the current work schedule will remain in effect. Clerk O'Grady advised the Board of Commissioners, the 2013 Open Space Trust Fund Application deadline is August 29th.

Captain Hippe stated the Police Department is looking into upgrading their current dispatching/computer system with InfoShare. The current system lacks direct interface with the in-house computer system. The new system will provide an e-ticketing system, incident reports, generate business and employee files. The new system will also provide cost savings to the Violations Bureau. He added that Chief Rose had received a verbal OK from the prosecutor's office to use \$30,000 of confiscated funds for the upgrade. The original cost was approximately \$176,000 but InfoShare is looking for a partnership with the police department to utilize their software for a cost of approximately \$65,000.

Commissioner Anlian suggested contacting other municipalities using this product for their input and to discuss the e-ticket system with the Violations Bureau.

Attorney Boggia stated Avalon Bay is proposing a 30 year Pilot Program. He will be sending the Pilot Agreement draft to Ms. O'Grady and Dieter Lerch. He asked the Mayor and Commissioners to review the financial agreement.

DISCUSSION II

Commissioner Anlian stated he contacted Boswell Engineering regarding installation of a boat ramp on the Hackensack River. Mayor Fosdick asked Mr. Boggia to contact the Bond Counsel for advice on potential capital bonds.

ADJOURNMENT

Mayor Fosdick adjourned the meeting at 8:25 p.m.
