### **DISCUSSION**

2013 Salary Ordinance – Clerk O'Grady to prepare Ordinance for the August 13<sup>th</sup> meeting.

Capital Bond – The Mayor and Commissioners reviewed the Debt Analysis.

Mayor Fosdick stated the new Fire Pumper and Equipment will cost approximately \$1 million.

DPW Superintendent stated \$750,000 will be needed for Roads – Euclid Avenue from Hobart Street to Route 46; Christie Street from Teaneck Road to the Municipal Pool, and Brinkerhoff Street from Main Street to the Municipal Pool.

Commissioner MacNeill advised new lighting is needed for Veterans Park and the Soccer Field. The cost will be \$1.5 million and would like to use the proceeds from the sale of Challenger Road. The Municipal Pool needs \$200,000 to renovate the bathrooms, new filtration system, etc. He advised the Village was awarded a \$59,000 matching grant for Hobart Street Park.

The Mayor asked Supt. O'Grady to discuss with OEM Coordinator Hansen new generator costs.

The Capital projects will be further discussed at future meetings.

#### **REPORTS**

**Commissioner MacNeill** advised the Pool Manager has resigned. Two residents have applied for the vacant Pool Commission seat. Clerk O'Grady will prepare resolution for next meeting appointing Karen Conway.

**Mayor Fosdick** advised the Rotary Installation will be on Wednesday, July 10<sup>th</sup> at Don MacNeill's home in Maywood at 6pm. July 17<sup>th</sup> is the Board of Chosen Freeholders meeting at 4:30 pm.

**Superintendent O'Grady** advised he is losing an employee who has been hired by the Hackensack Police Department.

Village Attorney Boggia advised Samsung would like to use the vacant lot on Challenger Road. Since the lot is for sale and possible environmental testing, the lot cannot be used. Starplex is interested in purchasing the land, and would like to use the vacant lot for fair market rent. He stated Chase Partners would like their \$35,000 escrow returned. Clerk O'Grady will check all bills to determine if there is a balance or deficit. Commissioner Boyd inquired as to the progress of Avalon Bay and the scheduling of upcoming meetings. Mr. Boggia stated Ron Ladell is on vacation and has a scheduled conference call on Wednesday. He did advise that Avalon Bay wants a 30 year pilot program. Commissioner MacNeill raised his concern about design issues. He would like Fred Rosen to attend meetings with Avalon Bay.
