Lawrence Stefanile Transition Report Conference Call

Mayor Fosdick commended Mr. Stefanile for all the hard work he has done for the Village and that he will be missed.

Mr. Stefanile stated he has worked for the Village since 1967 and added Ridgefield Park is a gold standard municipality.

Mr. Stefanile advised the SAM (Systems Administration Management) Program is a very high priority to keep active. The Village's active certification extends to January 2017. His recommendation is to have the Village's Financial Officer handle the re-certification process. The DUNS and CAGE numbers are required on applications and advised not to change those numbers.

Mayor Fosdick asked if he could recommend a replacement. Mr. Stefanile advised he could not.

## **HEARING OF CITIZENS**

No citizens present.

### **REPORTS**

Commissioner Boyd inquired if we received any correspondence from Asw. Caride regarding the talking traffic light. Commissioner Boyd asked what proper protocol is for Eagle Scout Projects. Commissioner Anlian advised the municipality does not contribute funds for Eagle Projects. Mayor Fosdick added the scouts are to raise their own funds and solicit for materials. He added the Village has made materials available and assisted. The Board of Commissioners was in agreement that Scouts are to raise their own funds.

**Commissioner Poli** stated he received a complaint from a resident who received a bill from Holy Name Hospital's EMS. Since the Village has a contract with Holy Name, he called and inquired. He was told it was an error. He would like something on the Website and in the Newsletter warning residents.

Commissioner MacNeill stated the Civic Center needs work. As per the recent air quality report, the second floor cannot be used. He is currently getting prices for mold and asbestos removal. He would like the Civic Center to be utilized as a Recreation Center. The fireplace room can become home for the Board of Recreation. The thought is to remove the organ, do some light renovations, install televisions, a movie screen, air conditioning, fans. Commissioner Boyd asked if the insurance will pay for mold remediation. Commissioner MacNeill will inquire with GJEM Insurance. He advised the Board of Recreation is adding competition cheering to its program.

**Commissioner Anlian** advised as per Sustainable Jersey, an ordinance will need to be adopted to form a Green Team and members would need to be named.

**Mayor Fosdick** asked the following correspondence to be distributed: Emergency Prophylaxis Plan, Congressman Pascrell Jr. Mayor's Breakfast, Hatch Mott MacDonald memo and Booster Club flyer. He advised, as per the Police Department, it is permissible to allow exclusive parking for a handicapped parking space.

**Clerk O'Grady** inquired if the 2016 Salary Ordinance can be introduced at the next Regular Commissioner's meeting. She was advised to place it on the August 9, 2016 agenda. Mrs. O'Grady inquired if "\$5 for Jeans on Fridays" can be implemented to raise funds for the "Village People" Breast Cancer Walk team. The Board of Commissioners agreed.

**Superintendent O'Grady** advised the "Leonard Hatton Way" sign is in. He inquired about a sign for Michael Zinzi. Mayor Fosdick stated although he grew up in Ridgefield Park he wasn't a resident. Mr. O'Grady advised the band festival was a bust – approximately 80 people attended. The lightning detection system went off at 4:30 and the field had to be evacuated. The DPW overtime for the event was approximately \$800. He also advised the Village had a dry weather overflow on Monday – the County regulator was clogged and had to be reported to the DEP.

**Attorney Boggia** advised a staff member from Asw. Caride's office had called and asked if there were any proposed changes to the legislation regarding the Pedestrian Bridge. Mr. Boggia stated he advised there weren't any. The staff member then advised Asw. Caride will have it listed for the fall legislative agenda.
