#### **REPORTS**

Commissioner Olson advised the archery clinic started last weekend – approximately 60 participants and 6 parents volunteered to coach. The Styrofoam container at the DPW caught fire and damaged the canoe container. The container needs to be replaced. He met with the "Black Lives Matter" group and they will be at Tuesday's meeting. The cheering mats will be going to the High School and the old High School mats will go to the cheering group. Tree Lighting is 1<sup>st</sup> Sunday in December.

**Commissioner Gerken** sent a letter Garden State regarding the fireworks. Fall flowers will be planted shortly.

**Chief Rella** advised swearings-in of 2 new police officers will take place on Tuesday, October 13<sup>th</sup> at 6:45pm. The Police Department has been storing the meter money – any plans to get it to a bank? Commissioner MacNeill stated he will look into it on Tuesday with Vince Buono (CFO).

Attorney Boggia stated Ken Ochab proposed to amend the zoning ordinance. An overlay on Industrial Avenue will allow residential – not sure if that's the way the Village wants to go. The Village does not have a lot of industrial zoning in this area. Star Candle had reached out to George Fosdick – they want to redevelop. The Bogota Golf Range is proposing to be a distribution warehouse –  $\frac{1}{2}$  of property is in Ridgefield Park. 60 Challenger Road has been approved with 500 units – hope to close title at the end of this year.

#### **CORRESPONDENCE**

09-16 Ken Ochab – Industrial Avenue Overlay Zone

Attorney Boggia advised Star Candle is ending business in Ridgefield Park – would Planning Board entertain the idea of residential units along the riverfront. Allowing an overlay zone will allow residential development. There would be multiple issues – traffic, road widening, train noise, trains blocking crossing. If Commissioners pass an ordinance amendment allowing an overlay zone, it would mean a major application by Star Candle – approx. 150 units.

Commissioners MacNeill and Olson are against residential redevelopment – huge safety issue with trains blocking the crossing for extended periods of time.

Ordinance amendment place on hold for now - Phil Boggia will contact Star Candle's attorney.
