#### **COVID-19 Updates**

Capt. Gneiding advised the police department is working 12 hour shifts during the health emergency. 4 officers are on quarantine -1 tested positive and 3 are out due to exposure to the virus.

#### **COMMISSIONERS REPORTS**

**Mayor Fosdick** stated for the March 19<sup>th</sup> Caucus meeting, all Commissioners and staff in attendance did follow social distancing protocol. Since the May 24<sup>th</sup> Regular Commissioners meeting was cancelled, the Board of Commissioners held a Special Meeting on April 2, 2020 via teleconference call. This was properly advertised and posted on the Village website. Since no one from the public was on the April 2<sup>nd</sup> teleconference call, Mayor Fosdick again announced the April 30, 2020 retirement of Police Chief Ed Rose. A Closed Session Meeting Notice was properly advertised for today's interviews for the Police Chief position. Commissioners Kohles and Poli assisted in the interviewing process since they are not candidates in the May election.

Clerk O'Grady stated that she and Capt. Gneiding shopped for an ill resident after a call was received from the resident's friend asking for assistance and was transferred to numerous departments. The Mayor and Commissioners stated these calls should be handled by OEM. Financial Disclosure Statement information has been sent out – filing deadline April 30, 2020. There are a few employees that still have 2019 vacation time left– employee handbook states carried over vacation time must be used by the end of the first quarter. A resolution will be prepared to extend the deadline to use unused 2019 vacation time to December 31, 2020.
