MKW Associates – Veterans Park

MKW Associates were in attendance and gave a presentation on the proposed renovations to Veterans Park. The design is to maximize and improve the use of space. Renovations include a 400-meter track around the football/soccer field and synthetic turf. The presentation will be forwarded to Ken Ochab, Planning Board, Zoning Board and Shade Tree Commission. It will also be presented at a town meeting for residents to view. The project will take approximately 3+ years to complete. MKW Associates suggests the Village hire a construction manager that will be on site on a regular basis when construction commences. Approximate cost is \$13.972 million.

Commissioner Gerken advised the Welfare Director is still out but the office is covered. There is money in the Environmental Commissioner budget for interpretive signage for the Nature Preserve. He spoke to Santori Bros. and received a verbal commitment to honor the 2007 pricing for fireworks for the first year the Village books. Still need approximate costs for a sound system and police overtime for fireworks – DPW estimated overtime is \$5,000.

Commissioner Portorreal advised as of right now, the pool is \$14,000 in the red. The pool collected \$22,780 in daily passes. The Pool Commission needs to appoint a President, Secretary and Treasurer in December and submit a budget for next season. The Board of Commissioners make the decision to re-appoint Commission members.

Commissioner MacNeill advised Ridgefield Park's So. Bergen Loss Accident Frequency for 2020 is 2.61. In 2018, it was 1.58 In 2019, it was 2.20.

Mayor Anlian met with the Library Trustees and they would like to raise salaries of Library personnel in accordance with the State Association. The formula is based on assessed property of the Village.
