# **DISCUSSION I**

### 2021 Meeting Dates

### **Unused 2020 Vacation Time**

Employees can carry over 2 weeks of vacation time and it must be used by July 1, 2021. Department Heads can carry over 3 weeks. Commissioner Gerken will draft a memo.

Mayor Anlian suggested a provision be made to the resolution that the green purchasing policy is not mandatory.

## **REPORTS**

**Commissioner Gerken** advised the Environmental Commission has received an additional \$98,000 approval for the Nature Preserve. 16 bid packets were picked up for the boardwalk trail. The bid opening is scheduled for November 24<sup>th</sup>. Next Monday, the 4<sup>th</sup> of July Committee is meeting to discuss the fireworks.

**Commissioner Olson** stated he attended the Board of Recreation meeting. The holiday vehicle parade was discussed. The High School parking lot cannot be used – he suggested the pool parking lot. The Arts Association Outdoor Fair is this Saturday. The Pool Commission voted to pay the pool Manager for time he never put in for payroll - A timesheet was never submitted. Commissioners recommend the pool manager not get paid – there is not proof of hours worked. Commissioner Olson's 3 suggestions for the pool are 1. Run it as a utility. 2. Run as an operating department – Bd. of Commissioners will have more direct control. 3. Turn it into a recreational facility. The pool needs at least \$150,000 worth of work.

**Commissioner MacNeill** advised revenues are down at least \$600,000 so far this year. This does not include loss of any taxes. The Village is starting 2021 \$@ million short.

**Clerk O'Grady** stated she has received inquiries regarding sick time as opposed to workers compensation regarding COVID and quarantining. For workers comp – employees have to prove to Bergen Risk where they contracted COVID – extremely hard to prove. Employees must use sick time or apply foe COVID Emergency Paid Sick Leave. Since this was a Presidential election year – Christmas Eve and New Year's Eve still half days – yes. The December 8<sup>th</sup> Commissioners meeting is the installation of officers for the Fire Department – Court Room is limited to 25 people. Mrs. O'Grady will contact Dr. Bender for permission to utilize the High School gym.
