HEARING OF CITIZENS

REPORTS

Commissioner Gerken stated he is progressing with the 4th of July fireworks contract. The Rutherford Community Bank will perform on the 4th before the fireworks. Robert Bannon will sing the National Anthem. Holy Name Hospital is offering remote vaccinations for homebound residents and are looking to do a vaccination clinic in the Village. The ideal location would be the Civic Center since it is in the center of town and parking on the streets can be controlled.

Commissioner Olson stated the concession stand at the pool has been cleaned and painted - he found a used refrigerator. The open house took in \$20,000.00 in memberships. Certain resolutions need to be passed to re-certify for Sustainable Jersey. The Village needs to have a creative team to apply for Sustainable Jersey arts points. The concert schedule is almost finalized.

Commissioner Gerken advised there is now part-time help in the Health Department. May 17th is the pre-construction meeting on the Nature Preserve Project. Commissioner Gerken also advised this week is Municipal Clerk's Week.

Clerk O'Grady advised she has been receiving calls from organizations if the Village is having the 4th of July parade since they need to contract with bands – yes, the Village is having the parade. The Arts Association inquired if artists can sell their work at the Summer Artsfest – the Commissioners approved. The Arts Association needs to submit a certificate of liability insurance and hold harmless agreement to the Village for the Artsfest. Michael Alberque called to verify the fire department "mortgages" are forgiven – no, the fire companies are still responsible to make payments. Uber, partnering with the County, is offering free rides to vaccination appointments. Flyer will go on website.

Superintendent Monroe stated he met with the architect on the Municipal Building roof – they will start drawing up the specs.

Mayor Anlian stated the Street Fair will be held on Halloween weekend.

Attorney Boggia distributed a newspaper article on Keansburg's practices on vacation time/sick leave payouts.
