HEARING OF CITIZENS

DISCUSSION

Ridgefield Park Volunteer Ambulance Corps.

Representatives from the Ambulance Corps. were present and gave the Board of Commissioners an equipment inventory. 3 vehicles need replacement – 2 ambulances at approx. \$250,000.00 and 1 command vehicle at approx. \$80,000.00. Chief Nagurka stated they don't have 1 reliable ambulance at this time. Loaner vehicles are available as long as the ambulances are ordered and purchased. Mayor Anlian asked the members to ask other towns their experiences with loaned vehicles. A new vehicle cannot be approved tonight – need to consult the CFO. The Ambulance Corps. is also having difficulty in recruiting members. There are currently 12 active EMT members. Ridgefield just shut down their program. Mayor Anlian stated the Board of Commissioners are considering reimbursing training time to the Fire Department and will consider the same for the Ambulance Corps. Mayor Anlian suggested putting in a short article in the newsletter to encourage people to join.

Ridgefield Park Fire Department Training Reimbursement

The Board of Commissioners discussed the drafted memo to Chief Antola regarding incentive payments. Building Department permit fees should be half price. Fire Department loans should not be cancelled. Mayor Anlian will revise the memo and re-distribute.

REPORTS

Commissioner Olson advised Summer Recreation registration went well – over 100 applicants. The Artsfest was a great event – Mayor Anlian asked that Main Street not be blocked off next year. Concerts in the Park begin on June 26th. Comm. Olson would like a food truck at the concerts. Tables and chairs have been purchased for future events. Public Arts Champions resolution will be prepared for the June 22 meeting. Bob O's will be the concessionaire at the pool – working on the contract.

Superintendent Monroe stated for 2022 Local Aid – will apply for paving of 6 streets. Overpeck Avenue is concrete – Commissioners do not want asphalt overlay.
