HEARING OF CITIZENS

REPORTS

Commissioner Portorreal advised she interviewed Stephen Mazella for the Social Media Coordinator position. He is very interested and would like to start immediately. He would need an external hard drive. He would be expected to cover all news in Ridgefield Park. Mr. Mazella will be invited in on October 12th to discuss details.

Commissioner Olson advised he has 3 quotes for the gazebo repairs and for the Nature Preserve tree sculpture. Resolution will be prepared for the October 12, 2021 meeting.

Clerk O’Grady advised there has been numerous complaints regarding the DPW calendar. Complaints have also been received regarding the increase in taxes and how the 4th quarter taxes are due less than a month after the 3rd quarter taxes. The Health Office needs coverage from 3pm – 4:30pm.

DPW Superintendent Monroe stated the CSO Agreement needs to be signed and submitted. The DPW mechanic is retiring in March – need to discuss salary range.

Mayor Anlian stated the K of C vs. Masons softball game is Saturday morning. October 16th is the K of C 100th Anniversary Dinner. Joe Romano is to be appointed as an Associate Member of the Shade Tree Commissioner – resolution to be prepared for the October 12, 2021 meeting.

DISCUSSION

Ridgefield Park Fire Department – Reimbursement Incentives, Fire House Issues, Consolidation

The Board of Commissioners and Firefighters discussed Mayor Anlian’s Sept. 6, 2021 memo.

A, Incentive Payments to Firefighters

Michael Alberque stated when the committee originally met with the Board of Commissioners, they were only looking for reimbursement for members traveling to the academy for school. LOSAP is the incentive for retention. Reimbursements over \$600 is reportable income.

B. Percentage should be changed to 25% and life member with 25+ years are automatically eligible.

C. Clothing Allowance and Officer stipends will be effective for this year.

Discussion of Firehouse Consolidation

George Fosdick stated the goal is to preserve the RP Volunteer Fire Department. He distributed a memo and discussed major issues: response times and numbers, rosters, rules and regulations, officer requirements, budget, fund drive, loans, etc.

Mayor Anlian advised the Village is looking to hire a consultant to review the Fire Department and provide recommendations.

At this time, members of the Fire Department left the meeting.

Working Remotely

Commissioner MacNeill stated the Village should not permit employees to work remotely. Employees have the option to take family leave.
