COMMISSIONERS REGULAR MEETING MINUTES RIDGEFIELD PARK November 10, 2015 7:30 PM

APPROVAL OF MINUTES

Motion by Commissioner Boyd, seconded by Commissioner Poli to approve the minutes of the Commissioners Regular Meeting of October 27, 2015.

PAYMENT OF BILLS

Motion by Commissioner Boyd, seconded by Commissioner Poli to approve the payment of bills in the amount of \$4,820,889.23.

COMMISSIONERS REPORTS

Commissioner MacNeill advised the Veterans Park bathroom renovations are in the 11th hour and will be ready for the spring.

Mayor Fosdick reminded all the Veterans Day Ceremony is tomorrow at 11am at the Monument. Friday, the High School will be playing Orange in the state football playoffs.

HEARING OF CITIZENS

Noel Cote, resident, stated he was at a meeting a few weeks ago and voiced his concern about the Lincoln School traffic issues. He advised there is a definite improvement and would like to thank Chief Rose and the Police Department.

Walter Richter, resident, inquired about the stop sign on South Main Street behind EDI. He believes it is above the maximum height and it is on a telephone pole. He believes it should be on its own pole. Mrs. O'Grady will inform Chief Rose of his inquiry.

Mayor Fosdick advised the Police Department is researching an LED illuminated stop sign for the intersection of Railroad Avenue and Mt. Vernon Street.

November 10, 2015

Tom Blumenthal, resident, inquired about the Caucus Agenda item listed regarding the Historic Preservation Commission and signage. Commissioner MacNeill advised the HPC would like to allow lighted "open" and menu signs.

Mr. Richter asked if the Village has an ordinance in place for neon signs. Commissioner Anlian responded it depends on the location of the sign in the store.

Mr. Blumenthal stated Lulu's sign has been temporary for two years and asked when they will comply with the regulations of the HPC.

Commissioner MacNeill advised most businesses are under-capitalized and signage is very expensive. Commissioner Anlian added the first two years of a business is critical. They need to be given the opportunity to get established. The Village does not want to over-burden the store owners. The Commissioners feel justified in taking this approach.

Mr. Blumenthal asked if the Board of Commissioners have considered discounting the taxes on the buildings on Main Street in hopes the owners would lower the rents. Commissioner Anlian advised legally that cannot be done. Commissioner Boyd added the Village does not own the buildings nor have control over the rents. Mayor Fosdick advised at one time there was money set aside in the budget to develop a Chamber of Commerce and for store owners to enhance Main Street. They never applied for the money. Main Street is narrow and most stores are too small. The small shops tend to struggle. One of the main issues with Main Street was parking, now there are lots on both the north and south ends of Main Street. The Historic Preservation Commission regulations may be a hindrance. We have to remember the stores on Main Street are not the only stores in the Village. Commissioner MacNeill added the "named" stores want square footage and parking.

Mr. Blumenthal inquired when the infrastructure will begin on the Eagle's Nest Development. Commissioner Anlian replied it should begin next year. This development will be beneficial to the Village.

Mr. Richter inquired if there is anything new to report on the Challenger Road parcels. Commissioner Boyd stated the Village still owns them. Mayor Fosdick added three developers are interested in the parcels. Negotiations have to be handled confidentially.
