### **CORRESPONDENCE:**

Letter read from Hook & Ladder Company No. 2, Ridgefield Park Fire Department regarding the acceptance into membership of Ronald N. Winkelman. Motion by Mayor Fosdick, seconded by Commissioner Davis that Ronald N. Winkelman be accepted as a member of Hook & Ladder Company No. 2. On roll call Commissioners Anlian, D'Auria, Davis, Storer and Mayor Fosdick voted "YEA".

### **UNFINISHED BUSINESS:**

Commissioner Davis announced that this was the time and place for a public hearing on a BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS IN, BY AND FOR THE VILLAGE OF RIDGEFIELD PARK, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$500,000 TO PAY THE COST THEREOF, TO APPROPRIATE STATE AND FEDERAL GRANTS, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS. No one wished to be heard. Commissioner Davis explained there was \$330,000.00 available in grants for bond ordinance projects. Motion by Commissioner Davis, seconded by Commissioner D'Auria, that this Ordinance pass its second and final

reading and be duly published in the Record. On roll call Commissioners Anlian, D'Auria, Davis, Storer and Mayor Fosdick voted "YEA".
