### **ROLL CALL:**

### **APPROVAL OF MINUTES:**

### **SPECIAL REPORTS:**

Mayor Fosdick announced the services for Memorial Day were 9:30 A.M. Fire Department Service and 11:00 A.M. Veterans Service at the monument on Euclid Avenue.

Commissioners Anlian, D'Auria, Davis and Storer had no reports.

### **CORRESPONDENCE:**

### **HEARING OF CITIZENS:**

Rosemarie Toomey, 75 Hackensack Avenue:

Doris Conley, 22 Bergen Avenue:

Mrs. Conley took the boat ride on Earth Day on the Hackensack River. She stated the Little Ferry side of the river looks good but the Ridgefield Park side looks bad. She thought it would be nice to plant trees or build a retaining wall.

Frank Gazillo, 197 Brinkerhoff Street:

Still water behind his home hasn't been touched in years.

Mayor Fosdick said the Turnpike Authority is going to try and clean this up.

Mr. Gazillo said the water is deep enough for a child to drown and there is no fence.

Alan O'Grady stated he would give the Turnpike Authority a call to see when they will

do the clean up as the fence cannot be put up until after this is done as the equipment they use need the space for cleaning. Mr. Gazillo also asked if Brinkerhoff Street could be patched even though it is concrete.

Mayor Fosdick stated they were trying to catch up on street paving but at the present time they are lacking the funds.
