- 1. Fire Official is moving the Fire Chief's Office. A part-time secretary will be hired for 25 hours per week with no benefits. Suggested salary was \$17,000.00
- 2. Tuesday, November 11 at 11:00 am ceremony at Monument for Veteran's Day
- 3. Eagle Scout proclamation needed Tuesday.
- 4. Police Department is replacing two sergeants, McEntee and Brooks. 10 candidates were tested. Wednesday, November 12, final four will be interviewed.
- 5. Friday meeting was held at Senator Weinberg's Office with the Executive Director of the Turnpike Authority to discuss Pedestrian Bridge. Stephen Boswell explained there were no engineering problems and the Executive Director agreed. At meeting held in 2005, all was okay, now the Authority has a policy for no bridges. Authority was not aware of our court settlement. Dr. Boswell suggested the bridge be made a "Signature Bridge" for the north end of the turnpike.
