## **HEARING OF CITIZENS**

Antonio DiVerita, resident, complained about the parking restrictions, snow removal and the DPW. Mr. DiVerita stated the DPW doesn't clear the corners of snow like in years past, there is no signage on DPW vehicles and the DPW trucks should be parked in the garage at night.

Mayor Fosdick stated that he had been approached by residents of Cliffside Park and was told that our DPW is the best around. It has been a hard winter  $-2^{nd}$  coldest February on record. The Village is an older town with narrow streets. Most all apartment buildings were built with no provision for off street parking. There are still some streets with snow 3-4' from the curb. The parking restrictions will be lifted when all emergency vehicles can pass safely through all streets. Hopefully the ban will be lifted by the end of the week. The DPW does the best they can. If they plow too close to the curb, residents complain about their sidewalks. Some DPW trucks are kept outside because we have more trucks than in the past.

Walter Richter, resident, complained some residents are not in compliance with clearing their sidewalks of snow and ice. He inquired whose responsibility is it to monitor. Mayor Fosdick responded that regulation is enforced by the Police Department.

Mr. Richter inquired if there have been any proposals for the VFW property. Mayor Fosdick responded no.

Mr. Richer inquired on the status of the projects in the Village. Mayor Fosdick stated Matrix is in the process of conducting their environmental studies. Skymark has spent millions of dollars redesigning their plans to accommodate the eagles. An impact study is in the process of determining how the increase in population will affect the Police Department, Fire Department, and Ambulance Corps. and schools. There shouldn't be an impact for the Fire Department, some impact for the Police Department and Ambulance Corps., and minimal impact on schools. Mr. Richter asked how Skymark will be accessed. Mayor Fosdick responded via Rte. 46 and Challenger Road.

Mr. Richter inquired on the Pedestrian Bridge. Mayor Fosdick replied it will eventually happen.

Mr. Richter inquired if Riverside Medical owns the old bank property located on Lincoln Avenue and Mt. Vernon Street. Commissioner MacNeill responded yes.

Mr. Richter inquired as to why Ridgefield Police were working off duty services in our town a few months back. Mayor Fosdick advised we didn't have enough officers available at the time.
