## ROLL CALL\*\*\*\*

Those present were Commissioners Anlian, Boyd, Poli and Mayor Fosdick in the Chair. Commissioner MacNeill was absent.

## APPROVAL OF MINUTES\*\*\*\*

Motion by Commissioner Boyd seconded by Commissioner Poli to approve the minutes of the Commissioners Meeting of January 27, 2009. On roll call Commissioners Anlian, Boyd, Poli and Mayor Fosdick voted "YEA".

## SPECIAL REPORTS\*\*\*\*

Mayor Fosdick announced the retirement of Village Clerk Sarah Warlikowski effective April 30, 2009. Mrs. Warlikowski has been employed by the Village for 25 years, having served as the Village Clerk for the past several years.

Mayor Fosdick read a proclamation for - READ ACROSS AMERICA.

### PAYMENT OF BILLS\*\*\*\*

Motion by Commissioner Boyd seconded by Commissioner Poli to approve the payment of bills in the amount of \$3,788,627.13. On roll call Commissioners Anlian, Boyd, Poli and Mayor Fosdick voted "YEA".

## **HEARING OF CITIZENS\*\*\*\***

Rafael Moro - 139 Overpeck Avenue

Mr. Moro spoke concerning the lack of handicapped parking at Roosevelt School either on Highland Place or Hazelton Place. He stated his wife is handicapped and there is no place for her to park. Mr. Moro presented the Board of Commissioners with a request for accessible parking at Roosevelt School, pictures of the area, and the Guide to Disability Rights Laws.

Mayor Fosdick explained that Sgt. Maglione, our Traffic Officer, was hit by a car while on duty this week. However, Chief Lee will investigate the matter and will be in touch with Mr. Moro.

Ray Ziemba, 101 Overpeck Avenue

Mr. Ziemba said he had spent a lot of time in Trenton this week listening to complaints of a lot of people wanting property tax relief. He said we are the second highest State in the nation when it comes to property tax. He said we must reduce the school budget by 10% and the town budget by 10%. Municipal salaries and benefits cost the residents. He also spoke concerning arbitration.

Mayor Fosdick said we are preparing our budget and said he was in receipt of a Tax Analysis from our Tax Assessor. Mayor Fosdick said Ridgefield Park ranks 28<sup>th</sup> out of a possible 70 taxing districts. He said one of the major problems is fixed costs or spending such as pensions, insurance and union contracts. He explained that one tax point increase in tax rate equals approximately \$160,000 of spending. In order to offset increase of one tax point, you would need a new ratable equal to \$6,700,000 assessed value.

Mayor Fosdick reported presently Avalon Bay for the time being has been put on hold. Contrary to initial reports, Skymark Property did not go bankrupt.

Mayor Fosdick reported after three years we have completed an arbitration process for 2006, 2007, 2008, 2009 and 2010. We did not have a contract with the Police Department until now and Mayor Fosdick said he doubts very much that the state will vote to remove arbitration.

Mr. Ziemba asked Commissioner Boyd with property values going down and tax bills going out in August, will our taxes be adjusted?

Commissioner Boyd reported people are filing tax appeals. Mayor Fosdick said with the current ratio, our ratio is 95.21% Commissioner Anlian said that if all the property goes down in value we have to raise the same amount in taxes.
