Mr. Salerno was Chairman of the Fourth of July Parade Committee for 25 years, was a past member of the Ridgefield Park Board of Education and was active with the Boy Scouts. A moment of silence was also held for Ron Weber, former Board of Education Administrator, who passed away. Mr. Weber attended and graduated from Ridgefield Park Schools. In high school he was president of his class and captain of the football team.
