The flag salute was led by Mayor Fosdick.

#### APPROVAL OF MINUTES

Motion by Commissioner Boyd, seconded by Commissioner MacNeill to approve the minutes of the Commissioners Regular Meeting of August 12, 2014.

On roll call, Commissioners Boyd, MacNeill, Poli and Mayor Fosdick voted "YEA". Abstain: Commissioner Anlian

#### **PAYMENT OF BILLS**

Motion by Commissioner Boyd, seconded by Commissioner Anlian to approve the payment of bills in the amount of \$3,729,720.10.

On roll call, Commissioners Anlian, Boyd, MacNeill, Poli and Mayor Fosdick voted "YEA".

On a motion by Mayor Fosdick, seconded by Commissioner Boyd, Megan Elliffe be accepted as new member of the Village of Ridgefield Park Volunteer Fire Department subject to approval by the New Jersey State Firemen's Association.

On roll call Commissioners Anlian, Boyd, MacNeill, Poli and Mayor Fosdick voted "YEA".

Commissioner Boyd reminded all the Annual Street Fair is Saturday, September 20<sup>th</sup>.

#### **HEARING OF CITIZENS**

Tammy Laverty, resident, stated she was at the Teaneck meeting regarding the CSX trains. She asked what is on the trains and if Ridgefield Park was thinking about getting together with the surrounding towns to get information from the railroad.

#### September 9, 2014

Mayor Fosdick responded the Village knew what chemicals were being transported before it was made public via the media. The greatest hazard is not knowing what is being transported on the interstate highways. Gasoline tankers pose the greatest hazard. The Village does it's best to be prepared. The railroads are controlled by the Federal Government. 20 years ago, a nuclear bomb passed through the Village by rail.

John Russo, owner of Cosmic Wheel, raised his concerns about merchant/employee parking. He stated he has been in town for 19 years and although he knows something had to be done about the parking situation for customers, he believes that merchants and their employees should have a place to park as well. Parking on Village streets is very limited. Mr. Russo suggested a merchant parking permit and added that he is not the only merchant with these concerns. Something has to be done and is open to ideas.

Mayor Fosdick stated the Village instituted a parking enforcement officer based on merchants' feedback. Parking on Main Street should be for customers to help promote the businesses. The Commissioners will look into alternatives.

Commissioner Anlian advised perhaps an arrangement could be made with the church on Cedar Street and Bergen Avenue.

The clerk presented affidavit of publication, showing that advertisement had been made according to law, which was ordered filed. Commissioner Boyd moved the ordinance be adopted on second reading and final passage, which motion was seconded by Commissioner MacNeill and adopted upon a call of the roll.

On roll call, Commissioners Anlian, Boyd, MacNeill, Poli and Mayor Fosdick voted "YEA".

Mayor Fosdick thanked Megan Elliffe for joining our Fire Department, which is the oldest civic organization in Ridgefield Park. Be safe and have fun.

Mayor Fosdick advised this is not a closed session meeting.

A general discussion took place regarding the possibility of the VFW donating their land to the Village. Mr. Boggia will review and advise accordingly.
