COMMISSIONERS MEETING

Mayor Fosdick announced that this meeting is being held in accordance with the "Open Public Meeting Act, N.J.S.A. 10 4-6 et seq." notice of which was sent to the Record and the Star Ledger on January 2, 2005 and was posted on the Municipal Bulletin Board.

ROLL CALL*****

Those present were Commissioners Anlian, Boyd, Poli, Storer and Mayor Fosdick in the Chair.

FLAG SALUTE*****

The flag salute was led by Mayor Fosdick.

APPROVAL OF MINUTES*****

Motion by Commissioner Poli, seconded by Commissioner Boyd that the minutes of September 13, 2005 be approved. On roll call, Commissioners Anlian, Boyd, Poli, Storer and Mayor Fosidck voted "YEA".

SPECIAL REPORTS*****

Mayor Fosdick read letter to be sent to the Record in reference to an article on health benefits. He explained that although benefits are offered to the governing body, only one Commissioner has coverage and pays toward the costs.

HEARING OF CITIZENS*****

Ken O'Brien, 50 Spruce Avenue

Mr. O'Brien explained what happened when he had an accident on Main Street with a New Jersey Transit bus. As explained at a previous meeting, he complained that he was not interviewed by the police officer at the scene of the accident, and he wanted the report amended.

Mayor Fosdick stated that after the meeting, Captain Lee and Lieutenant Rose had met with Mr. O'Brien at his home to discuss the issue. Traffic officer, Sergeant McEntee, inspected the vehicle. The officer on the scene was also questioned. After the investigation, there was no reason to alter the report. Mayor Fosdick concurred with this decision.

Mr. O'Brien said New Jersey Transit will not pay for damages since they feel from the report that he was at fault. Commissioner Anlian suggested he go to Small Claims Court where a judge will make a decision.

Mr. O'Brien stated the officer did not do his job by failing to interview both parties.
