HEARING OF CITIZENS

Walter Richter, resident, inquired about regulations for storage pods. Commissioner MacNeill will speak with the Building Department. Also, the resident from 62 Teaneck Road is parking his truck at 54 Teaneck Road, which is in foreclosure. He asked how can he still park there and should he receive a summons. Commissioner MacNeill stated since it is private property, the Village has no jurisdiction – perhaps he has permission.

Umair Abbasi, resident, inquired if an exception can be made with regards to the parking of limousines on residential streets since his home does not have a driveway or garage. Mayor Fosdick advised the ordinance was based on complaints from residents and their inability to park. Mr. Abbasi asked if there could be a relaxation on the ordinance for a couple of months in case he needs to move. Mayor Fosdick responded no, exceptions cannot be made. Mr. Boggia explained the conflict was too many commercial vehicles were taking parking away from residents. Since there weren't any regulations in place, it encouraged more businesses to come to Ridgefield Park. Amending the parking ordinance was the best way to protect the residents and solve the situation.
