There are 47 participants; publicity has been sent through the schools, JC Promotions, and local TV channels. Announcement will be put on Village website.

September 23, 2010

Commissioner MacNeill reported: The Basketball and Volleyball court is complete. He then updated the Commissioners regarding Green Acres and the Multi-purpose field. The "at risk" letter is needed in order to move forward with the project and not risk losing funding.

Superintendent of DPW – Alan O'Grady stated that he received a letter from the Methodist Church asking for assistance to remove a dead tree.

The Board of Commissioners reached consensus approving the assistance of the DPW in removing the tree.

He then reported that the Village lost a few trees on Railroad Avenue and Hackensack Avenue in the storm the previous evening.

Commissioner MacNeill asked about the surge and the generator at Village Hall.

Mr. O'Grady stated that the generator kicked on when the power went out, but did not turn off when the power came back on, because generator runs until all power is returned. A new maintenance contract is needed for the generator, he will speak to Chief Rose regarding what they want in the contract. The Commissioners voiced the opinion that the police should continue to be in charge of the generator due to security issues.

He spoke to Bernard and Elizabeth Clancy, both would like to serve on the Board. He then asked if anyone had any preferences regarding the

town Christmas tree which used to be in front of the Village Hall. It was suggested a temporary tree be set up until a decision is made regarding the replacement of the tree.

Village Attorney - Martin Durkin thanked everyone for their efforts during the period he was out ill. He heard good reports regarding his staff who assisted the village in his absence. He then asked for a closed session regarding the Overpeck Park litigation with Bergen County.
