SPECIAL PRESENTATION

Wayne King – Re: Crown Carting Transfer Station

Mayor Fosdick shared an overview of the comments presented at a previous meeting by residents and council members of Ridgefield who oppose the application for Crown Carting's Transfer Station before the BCUA. He stated that before the Board of Commissioners decides to do or not do anything they would like to hear from both sides.

Mr. Wayne King and Mr. Chris Boel of Crown Carting addressed the Commissioners. They own the property where the transfer station would be, currently their carting station is there. The current zoning permits the facility. They hired an engineer to do the ground work. The BCUA hearing is next month. They shared a rendering of what the facility would look like. It is a self generated recycling facility. It will service only their own four trucks, 99 tons per day. The separating will be done in a closed building. The material is construction debris. They did a traffic study 60 trucks pass the corner of Church and Edgewater, four are Crown Carting. Trucks are not carrying garbage as originally thought. There are weekly visits by the DEP. The facility they built in North Bergen exceeded the DEP regulations. They ran this facility for five years with no violations.

Mayor Fosdick gave a copy of the handout from the Ridgefield residents to Mr. King.
