Compliance with January 1, 2013 Narrowbanding Deadline

Doug Hansen, Rodney Wagner, and Rich LaTour attended the meeting to participate in the discussion regarding the federal mandate to comply by January 1, 2013. Mayor Fosdick stated that he would like a unified approach by all departments. The band width will go from 25 kHz to 12.5 kHz. The DPW is not affected. Equipment made after 2001 is compatible and can be reprogrammed. The Fire Department will have to replace only two radios. The police desk can be reprogrammed. Mayor Fosdick asked that the input from the departments be put together and a recommendation made to the Commissioners for a unified approach to compliance.
