SPECIAL PRESENTATION

NJ Wave Swimming

Mr. Ken O'Reilly gave an overview of a proposal by NJ Wave Swimming to temporarily cover the Ridgefield Park swimming pool during the winter. NJ Wave Swimming would use the pool for swim team practice and lessons. They would pay all operating and construction expenses. ADA required equipment and winterization of the pool would also be at their cost. A rental agreement paying the Village for the use of the pool would be negotiated. They are considering a bubble type structure which would be removed to off site storage during the summer months while the Village residents are using the pool. They would construct a temporary structure leading to the bathrooms. Permanent anchors for the structure would be in place year round. These anchors would be flush with the ground and blend into existing pavement. NJ Wave Swimming is a non-profit organization.
