They participated in 15 drills and 16 in house training nights, He then welcomed new members Carlos Munoz, Jolly Thomas, and Isidro Fuentes along with one probationary member Victor Siri. The Rescue Squad received an award for the Governor for their work during hurricane Irene. They celebrated their 60<sup>th</sup> birthday in 2011. Rich Brown and Joe Savignano were made honorary members. There are 12 duty nights per year to check all compartments of the truck and all equipment. Chief Henkel thanked Fire Chief Rich LaTour, the assistant Chiefs, police department, Alan O'Grady of DPW, Doug Hansen of OEM for their support and cooperation. He thanked the outgoing Captain of the Ambulance Corps, Steven Fernandez as well as the incoming Captain Silvio Zapata.
