HEARING OF CITIZENS

Joseph Cuzo, resident, addressed the Board of Commissioners regarding an ordinance requiring criminal background checks for volunteers and employees who work with children. The initial cost would be funded by the Megan Kanka Foundation.

Mayor Fosdick responded that the Commissioners received the information forwarded by Mr. Cuzo. The Commissioners have checked with the surrounding towns for their ordinances regarding background checks. There are many ways to address this issue. They would like to look into it and call a meeting of all the organizations to discuss a proposal that would work for all concerned. Commissioner Boyd asked how often the checks are done. Mr. Cuzo responded every three years. She then asked about payment after the initial phase covered by the Kanka Foundation. Mr. Cuzo responded that the organizations would raise the money. Commissioner MacNeill suggested appointing Mr. Cuzo the point man to help organize the effort. Mayor Fosdick stated that they are not in disagreement, but have a process that must be followed.

Louise Maksymowicz, resident, asked who delivered the Village Newsletter, many people have not received it. Commissioner Poli stated he would mention this to the Boy Scouts who deliver the newsletter.

Walter Richter, resident, asked if the sidewalk on Hazelton Street was repaired. The Superintendent of Schools was in attendance and answered that it was being repaired with the construction project at the Roosevelt School. Mr. Richter then stated that speeding is a problem on Main Street by-pass and Teaneck Road. He then informed the Commissioners that the debris was removed from 9 Brinkerhoff. Commissioner MacNeill explained that the property belongs to the railroad which makes it difficult to deal with.
