Commissioner Poli reminded all the Ambulance Corps. Installation of officers is tonight during the Regular Commissioner's Meeting.

Commissioner MacNeill brought up concerns regarding a new electronic sign to replace the existing one in front of the Municipal Building. The current ordinance states that signage cannot flash. He would prefer the Board of Commissioners to present the sign, which would be used for informational purposes, before the Zoning Board. Village Attorney Boggia stated the Village is exempt from the ordinance. Mr. O'Grady added the sign would have been great to have had during Hurricane Sandy.

Mayor Fosdick reported last Friday and Saturday were the final stages of the Police Department Accreditation. This process has taken 2 years and feels RPPD did very well. The Police Chief will have a final interview in January 2013. Hose Co. No. 4 has been informed to submit a set of specs for a new fire engine. 2013 Budget sheets have been distributed to his departments and would like them submitted by the January 3, 2013 meeting. Luka's Restaurant will be moving to Bogota in the spring.
