Commissioner Anlian said he would like to see health insurance coverage broken down into different types of policies and what people would have to pay. Mr. McArow will look into tier policies. Mr. McArow explained with the Accreditation Program there would be a 5% savings on the policy. Mr. Altamura went over the higher deductibles for this year and the types of policies and coverage.
