Mr. Guralnik and his associate spoke about a proposal for use of property next to the Hilton Gardens. He proposed an amusement area which would consist of go-karts, bumper cars and a shooting gallery. He said the operation would be electrical in nature and would operate quietly and generate very little noise. Mr. Guralnik said he felt it would be a nice addition to the property and he did not think Hilton Hotel would object. He explained that he had spoken with people at Xanadu and were going to have bumper cars and go-karts at the Meadowlands Flea Market. He said although he had no experience in the field, his associate had experience in Israel and another associate had experience in California. Mr. Guralnik spoke about starting off small and gradually increasing the site. He talked about a canope over the tracks. He said safety for all was a major concern and there would be cars for children as well as adults.

Bill Betesh asked:

1. How long a lease do you plan on having on the property.

Mr. Guralnik said it would be a long term lease – 20 years.

2. The Village own the property and you still have to go before the Zoning Board and the Board of Adjustments to get approval to operate and site approval.

Mr. Guralnik explained who their planner was and said they are ready. He also said he has an architect.

- 3. Whenever you build on municipal property, prevailing wage laws have to be met.
- 4. What rent are you looking to pay for the use of the property.

Mr. Guralnik said a performance based arrangement.

Mayor Fosdick thanked Mr. Guralnik and his associate for coming. They left at 7:50 PM.

Discussion took place concerning the proposal and it was agreed by the Commissioners that this would not be a desired use in that area. They did not believe this was a good thing for the property out there. Mr. Betesh said the problem with performance based rent is it could only be a couple of months out of the year. He also said the insurance liability is one of the highest.

Mayor Fosdick said he would like to have Mr. Ladell back and perhaps hammer out a deal. We could talk about it and bring in the Board of Education. Mr. Betesh said the problem with a 20 year lease is if the company goes under, the property is tied up.

Mr. Betesh will contact Mr. Kafafian and let him know we are not interested.

REPORTS****

Commissioner MacNeill reported: Correspondence No. 03-38

 Meters – Commissioner MacNeill asked about the Cedar Street Parking Lot and its enforcement. He suggested parking meters of .25 cents for fifteen minutes. Mayor Fosdick said we would have to notify the Post Office regarding employee parking. Commissioner Anlian expressed concern that this might discourage shopping on Main Street

Mayor Fosdick asked about the merchants on Main Street and their fair.

Commissioner Boyd said supposedly August 29th they will tentatively have their fair.

Lieut. DiNiro said if you increase your parking meter amount you would have to increase your summonses. He said he rarely sees no parking space on Main Street. He did say that the parking meters are complete on Cedar Street. For the record, Cedar Street lot enforcement will notify the Post Office first.

- 2. Regarding Planters & Garbage Containers Commissioner Anlian has looked into it. Commissioner MacNeill said some people are using the garbage containers for regular garbage.
- 3. Loading Zones discussion was held concerning removing two of the Loading zones.
- 4. Bump outs, Trees, sidewalks. Commissioner MacNeill asked Commissioner Anlian to revisit the bump outs. Commissioner MacNeill said they collect garbage. He also asked if different trees could be planted.

 Banner – Commissioner MacNeill asked about having the banner restored to Main Street. Mr. O'Grady said it would cost approximately \$5,000. Commissioner MacNeill said when you put up a banner you will have to provide insurance.

Commissioner Boyd said there was no money in the budget, and Commissioner Anlian said we would have to make it a Capital Project.

Commissioner discussed the above matters, and it was decided to invite the store owners on Main Street to attend a Commissioners Meeting so they could express their views.

Commissioner Boyd reported:

- 3. Art Carlson's memo was distributed. Cannot answer until we speak with Dieter Lerch and Dr. Richardson. We need special permission to do this. The values set in 2005.
