#### **HEARING OF CITIZENS\*\*\*\***

# Mr. Ziemba – 101 Overpeck Avenue

There is a new administration in Trenton, open to ideas. He said the new governor is concerned about waste, lower school taxes, lower property taxes, health care, and freeze salaries. Mr. Ziemba said there was no increase in Social Security Benefits this year. He said there are ways to bring taxes down. He mentioned the recycling program. Said there is a church in Pennsylvania that says "give us your

wood". They take the wood and turn it into sawdust, and raise money for food baskets. He mentioned another pilot program, where they take food scraps and turn it into fertilizer and save \$80,000 in dumping fees. Mr. Ziemba spoke about possibly converting Village equipment to use another form of fuel other than gasoline. He said we have to come up with ideas. He said "garbage is one man's trash, but another man's goldmine."

Mr. Ziemba said there are 22 dogs on his block and asked about a dog run. He mentioned the horseshoe courts and said no one uses them, and a dog run would really be nice. The Mayor said the horseshoe courts are used in warmer weather. Mr. Ziemba mentioned the benches in McGowan park. The Mayor said we keep them up.

Regarding the schools, the Mayor said the people vote on the school budget. Regarding health care, it continues to increase and we have no control over it. Commissioner Boyd said the Commissioners have no control over the school budget. She said the State allows us to increase the budget 4% max; and the Mayor said sewer cost this year increased from 2009 from \$3,000 to this year \$55,000. He said we have already reduced the size of our Police Department and other departments are down.

Mr. Ziemba said the people need a break.
