**BOND ORDINANCE 2010-12** 

"BOND ORDINANCE TO AUTHORIZE THE INSTALLATION OF A SYNTHETIC TURF MULTIPURPOSE ATHLETIC FIELD AT VETERANS PARK IN, BY AND FOR THE VILLAGE OF RIDGEFIELD PARK, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$400,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS."

The clerk presented affidavit of publication, showing that advertisement had been made according to law, which was ordered filed. The Supplemental Debt Statement and Capital Budget Amendment Resolution were duly filed with the Division of Local Government Services. Commissioner MacNeill moved a public hearing be held on the ordinance and was seconded by Commissioner Poli. So ordered. Commissioner MacNeill read the ordinance by title on second reading. The Mayor then announced that all interested parties would now be given opportunity to be heard for or against the adoption of the ordinance.
