# **HEARING OF CITIZENS**

Walter Richter, resident, stated that there is no signage on the building at 152 Bergen Turnpike. Mayor Fosdick and Commissioner MacNeill stated that signage is not required as long as there is an address on the building. Walter Richter also stated that there is carcass' of what he believes to be rats, on the sidewalk, in the area of 152 Bergen Turnpike. He also stated that Creative Flooring located at 168 Bergen Turnpike has mounds of garbage and old carpeting in the rear of the building. He also stated that 2 Teaneck Road is being dismantled. He also stated that at 411 Teaneck Road, there is a Toyota parked in the driveway with no plates on the vehicle. Mayor Fosdick stated that if the vehicle is a commercial vehicle, it can be parked in the driveway. Walter Richter stated that this was not true that Sgt.
