#### **HEARING OF CITIZENS**

Thomas Blumenthal, resident, asked what the comparison of tax exemption vs. no exemption for the Eagle's Nest Development. Mayor Fosdick explained the PILOT program to Mr. Blumenthal and added the development would not happen without the abatement. The potential net value of the development is \$1 billion dollars. \$48 million in infrastructure work must be completed first. Commissioner MacNeill stated the PILOT program is over a 30 year period.

Mr. Blumenthal asked what would the benefits to the Village be and what would be the impact on Main Street. Mayor Fosdick stated he believes the development would enhance Main Street. There would be new people coming into the Village. Commissioner Anlian added more access to people would make Main Street vibrant.

John Welsek, resident, asked with the Board of Education's mistake, how will our taxes be affected. Mayor Fosdick stated the Board of Commissioners and the Board of Education are two separate entities. The Board of Commissioners does not participate in Board of Education policies. We do not know how the taxes will be affected.

## **December 22, 2015**

The Mayor has asked the Board of Education to address 4 critical points:

- 1. What and how it happened
- 2. What is the impact on the educational programs
- 3. What is the impact on the tax structure
- 4. What steps will be taken to prevent it from happening again.

The Board of Education has submitted a corrective action plan to the state.

Noel Cote, resident, stated he was at Monday's Board of Education meeting. The Business Administrator is on administrative leave with pay. The Board of Education hired a per diem BA at the rate of \$400 per day. The Board of Education went into closed session for 1.5 hours and resolutions were not readily available to the public for review. Mr. Cote stated he did ask Mr. Eric Koenig about the 6% increase in our taxes. He stated Mr. Koenig advised him the County mandated that increase.
