HEARING OF CITIZENS****

Kevin Nevins - 177 Brinkerhoff Street -

Mr. Nevins is President of the Ridgefield Park Baseball Organization. Mr. Nevins stated there is a need for more baseball fields since they have many more children playing. He suggested removing basketball courts and hockey rink.

Mayor Fosdick explained there were no immediate plans for park improvements. Drainage is responsible for bad condition of courts. Cost is prohibitive for study and corrections. Green Acres funds were used for construction of some park improvements, and they must remain in use.

It was suggested the area at the bottom of Brinkerhoff Street be used for a practice field. This facility would not take long to be prepared. Possibilities will be reviewed.

Mike Alberque - 122 Preston Street -

Mr. Alberque stated there is a conflict on the fields with out-of-towners.

It was explained that schools have first use; recreation next; followed by Ridgefield Park organizations; Ridgefield Park Softball Association uses Hobart field. Again, since the Village has used Green Acres funds, all facilities must be open to any out-of-towners.

Ed Palange - 107 Union Place.

He asked if permits were required for field use. It was told they are.

Mr. Palange spoke for the Senior Citizen group. they have lost money when they have had to cancel a bus for a planned trip due to lack of participants. He met with Commissioner Storer and asked if town bus could be used more. Commissioner Storer brought question to the Commissioners and reported to the seniors it was not approved. Mr. Palange said seniors had not explained what they wanted. They do not want service to shopping centers. They do pay overtime incurred when bus is used. They want buses to go further than 25 miles. Mayor Fosdick stated they will see what can be done, and it will be on a case-by-case basis.

E. Quigley - 75 Edwin Street -

Mr. Quigley is treasurer of the Senior group. The trip that was cancelled due to a shortage of participants was going to Huntington, approximately 50 miles away.

Mike Alberque - 122 Preston Street -

Questioned if geese problem was being addressed. Alan O'Grady is checking into it.

Mike Gioia -128 Gordon Street -

Mr. Gioia complained about a stockade fence his neighbor has around his pool is falling down on Mr. Gioia's property. He had photos to show problem. Issue will be brought to Doug Hansen's attention.
