HEARING OF CITIZENS:

Ken O'Brien, 50 Spruce Avenue:

First Mr. O'Brien complimented the police for their conduct when Victoria Kraljic

Secondly, he complained because he was stopped by the police and had to show his driver's license and he felt his civil rights were violated. He was critical of the Mayor, and demanded he resign.

Mayor Fosdick replied to Mr. O'Brien's complaints that his civil rights were not violated, and he would not resign.

Victor Sala, 380 Main Street:

Mr. Sala was concerned that a bus shelter was going to be installed in front of his home.

Mayor Fosdick explained NJ Transit is responsible for the installation and Mr. Sala should contact them.

Dominick Gentile, 388 Main Street:

Mr. Gentile stated a bus shelter would obstruct the view of a driver making a turn from Central Avenue and would be a safety hazard. Capt. Lee will ask Sgt. McEntee to call Mayor Fosdick regarding this matter.

William Beatty, 11 Main Street:

Mr. Beatty complained that the trains are blowing the whistles during the early morning hours. This is in addition to the shifting of trains.

Mayor Fosdick explained neither Ridgefield Park, nor any other municipality, has any control over railroad operations. CSX has pledged \$50,000.00 for an engineering study on the practicality of closing the Mt. Vernon crossing.

Mr. Beatty asked if there was a Village noise ordinance. EDI is loading trucks at 4:30 A.M. Mayor Fosdick stated the noise ordinance sets 7:00 A.M. as the earliest time this can be done.

Rosemarie Toomey, 75 Hackensack Avenue:

Mrs. Toomey asked the Commissioners to consider the slowing economy and the citizens when the defeated School Board budget is reviewed for reduction.
