#### **HEARING OF CITIZENS**

Matthew Reber, resident, would like body cameras mandatory for the Police Department, Ridgefield Park currently has dash cameras. Chief Rella responded that he will meet and show Mr. Reber exactly what the dash cameras actually show. Chief Rella stated the body camera program is rather expensive and would entertain it if the Police Department had nothing. He doesn't see a need for it right now. Footage from dash cams was successfully tested in court. Chief Rella stated he will reach out to him in the near future to arrange a meeting.

Mr. Reber stated he researched body cameras and believes the cost would be approximately \$30,000.00. Body cameras would provide more evidence – dash cams don't pick up everything. Body cams would benefit both the Police Department and citizens.

Commissioner Gerken stated there seems to be a solution before there is a problem.

Mayor Anlian thanked Mr. Reber for taking the time to write his email and for coming to the meeting. Ridgefield Park reminded all the Ridgefield Park Police Department is accredited and runs efficiently.
