Commissioner Olson advised Art Mora would like to hold an Art Fair on November 14, 2020 in the Cedar Street parking lot.

HEARING OF CITIZENS

Matthew Reber, resident, understands that Ridgefield Park does not have body cameras due to budget restraints. He does not have any issues with the Police Department. He feels it is imperative to do what is best for the community. Having body cameras will further re-affirm the position of Ridgefield Park – set a good example for others.

Jashaun Sadler, resident, stated he is reaffirming what Matt Reber said. He would like the Commissioners be pro-active instead of reactive. He would like to see our leaders share the same urgency. He has started a petition, via change.org, for an Antiracist RP School District. The petition has over 800 signatures. He emailed to both Mayor Anlian and Superintendent Bender and has not received a response. He would like to create a world with respect and create justice for all people. Mayor Anlian asked Mr. Sadler to resend his email since he does not recall receiving it.

September 8, 2020

Mayor Anlian responded to Mr. Sadler's remarks and stated the points he is making are very good and that his children should be proud. He also stated the Police Chief is working on the body camera issue and the Village simply not ignoring you.

Malik Sadler, resident, stated for a diverse town, it doesn't show in his teachers. Teachers have not talked to students about what has happened with George Floyd and the others. Mayor Anlian stated the Village does not hire people based on their race, ethnicity. They are hired by their education and qualifications.

Jazline Sadler, resident, stated she feels that the teachers don't care about what happened. Mayor Anlian told Ms. Sadler she is very well spoken and her father should be proud. He reassured Ms. Sadler that Superintendent Bender does care about all the students in the school system and that the Board of Education administers the school system.

Ruisa Sylvestri, resident, stated we need teachers of good quality. Mayor Anlian again stated the Board of Commissioners is not involved with the Board of Education. The Board of Education is a separate board.

Thomas Vercelli, resident, stated there is power in numbers. The reason he is here is there seems to be a lack of enthusiasm of what is of concern. He would like to see more pro-activeness. He believes it seems to be a question of privilege. The Board of Commissioners might not see the sense of urgency of body cameras. Are the police taking into account how others feel?

Commissioner Gerken stated there is currently a bill on the Governor's desk to sign to make body cameras mandatory. It was passed by the Assembly and State.

Paulie Boranian Jr., resident, advised they continue to do this because they feel it is important to have at lease a weekly protest. 2 people that have been to their protests have been threatened with gun shooting gestures because of the color of their skin. There are instances of people coming to Ridgefield Park and are being threatened. He feels it is important for these discussions to continue. They will continue attending these meeting.

Corey Klein, UBS Bank reminded the Board of Commissioners that formal action cannot be taken in closed session. Attorney Boggia advised the Board of Commissioner is aware.
