# **SPECIAL REPORTS**

Installation of Ridgefield Park Volunteer Ambulance Corps. Officers.

Commissioner Olson asked Chief Weidner to give his annual report. In the Chief's absence, Sylvio Zapata read the Chief's report. As per the Chief's report, the Ambulance Corps. responded to approximately 517 emergency calls which was an increase of 111 from last year. The Ambulance Corps. has 70 members comprised of Life, Probationary, Associate, Reserve, and Youth Members. Training continues to be a top priority, even more so with COVID-19. The Ambulance Corps. thanked the Board of Commissioners, Police Department, Fire Department, Rescue Squad, OEM, DPW and the Village Clerk's office.

Mrs. O'Grady administered the Oaths of Office to the Administrative Officers.

#### **January 12, 2021**

Commissioner Olson thanked the Ambulance Corps. for all they do, especially this year. They give a tremendous amount of time and the Village is grateful.

Mayor Anlian also thanked all the members and congratulated the new officers. He added, volunteers are the glue that keeps the Village moving forward. Thank you personally for what you've done and will do. Hope 2021 is better.

#### **HEARING OF CITIZENS**

Sharon Strowbridge, resident, stated the islands on Overpeck Avenue need to be dealt with. The islands are not being maintained and cars parked on Overpeck are getting hit – islands too wide. Her complaint is the islands, not the DPW. The islands need to be addressed and the road is terrible. She called the DPW and was told they are not maintaining the islands because landscapers are dumping their leaves on the islands.

Mayor Anlian agreed with Ms. Strowbridge. He stated the Grand Avenue islands were narrowed 15-20 years ago. The difference between the streets is that Grand Avenue was asphalt while Overpeck Avenue is concrete. This year and next year, the Village will be tackling a financial crisis but will put Overpeck Avenue on the priority list. He also stated he was not aware the DPW was not maintaining the islands.

Commissioner Olson advised that the DPW Superintendent was in attendance. He knew the DPW was pushing back on residents dumping their yard waste on the islands. Supt. Monroe stated there is no policy in place for the DPW not to maintain the islands. Supt. Monroe added the biggest issue of Overpeck Avenue is cost.

#### **COMMISSIONER REPORTS**

Commissioner Olson stated he received a letter which stated a DPW truck was sighted at a private house. Commissioner Olson stated the truck was being utilized by a volunteer 1st Responder. 1st Responders are entitled to utilize DPW trucks when doing home renovations - this is one of the few perks our volunteer 1st Responders have in town and the Commissioners are looking for others as a way to thank them. Commissioner Olson also stated a garbage truck and bus were recently sold at auction. The exhaust system at the Ambulance Corps has failed – will need a new system.
