COMMISSIONER REPORTS

Commissioner Portorreal advised she would like to discuss the Pool at the end of the meeting.

Commissioner Olson stated a plumber looked at the water fountains in the park and some are repairable.

Commissioner Gerken stated he is working on the fireworks contract.

HEARING OF CITIZENS

Joe Kenney, RP Arts Association & resident, gave an update on the Summer Arts Festival. The festival is taking place on June 11, 12 & 13. The Civic Center will have 3 days of art exhibits. The Arts Association is renting a stage from the County. The concert will take place on Saturday, June 12. There will be new performers this year. There are concerns: the stage is 30 feet in length and Grove Street has low hanging wires. The Arts Association would like Main Street closed off on the 12th from 4pm-9pm. This has been a widely publicized event – part of the County Art Crawl. Mayor Anlian stated closing Main Street will hurt the businesses and impact IGA. Mayor Anlian advised Joe Kenney to speak with IGA.

April 27, 2021

Tom Wilcott, resident, stated a number of the Village restaurants did well 2 years ago. The Commissioners need to keep in mind social distancing requirements.

Marly Gonzalez, resident, added that she doesn't think there will be an impact on IGA or other businesses.

Mayor Anlian thanked all for putting this program together.

Rafael Alfaro, resident, stated something must be done with the garbage/litter around the Village. The IGA and 7-11 parking lots are unsightly.

Mayor Anlian agreed that litter is a continuous problem.

Commissioner Olson stated the DPW cleans Main Street each morning.

Commissioner MacNeill stated the apartments above the businesses on Main Street are using the garbage receptacles for their personal use and put their garbage out on Fridays for Monday pick-up.

Marly Gonzalez stated the ordinances need to be enforced – commercial vehicles parking on the streets, residents doing mechanic work on vehicles in driveways.

Joan Carlson, resident, stated she complained about this years ago. The tenants take no responsibility – go after the landlords.

Mayor Anlian thanked everyone for bringing these issues to their attention.

Can the pool accept equipment donations – can be accepted via resolution. Can the pool fund raise – speak with CFO, may need to set up a trust account
