DISCUSSION

RP Fire Department

Mayor Anlian addressed the Fire Department and thanked them for coming to discuss the possible consolidation of the Fire Department structure. Currently the Village has 6 firehouses for 6 fire companies. The proposal would consist of the 6 firehouses consolidating to 1 or 2 firehouses. The preliminary location is the old Boswell building on Mt. Vernon Street, across the street from Hose Co. No. 1. All fire companies would consolidate and create 1 non-profit Fire Department agency. Since the companies technically own their firehouses, all companies would deed over the firehouses to the Village. The properties would be sold to offset the cost of the new firehouse. Each fire company must be in agreement to start the process. Mayor Anlian added he was shocked with the initial proposal but does agree it makes sense. All representatives in attendance tonight need to go back to their individual fire company and discuss/vote.

Commissioner Gerken stated they don't want to start the project and come to a roadblock – want to make sure the entire department is in agreement.

Michael Alberque stated he did look at the building, including the old pizza parlor building, and is pretty confident there will be sufficient room for the fire station. In the long run, this would be a cost savings to the Village. Loans were taken out by each fire company to modify their buildings for the apparatus. New guidelines would be put in place with a new building.

Justin DePena asked if the individual firehouses would be responsible if contaminants were found – Village's responsibility, no liability to firehouses. He also stated it make more sense to have 2 locations, 1 north and 1 south within the Village.

Connor O'Grady asked if the company votes had to be unanimous or majority – majority vote within each company; unanimous vote of all companies or would be a dead deal.

John Malool asked about the Fire Department mortgages – mortgages would be cancelled.

Ricky Pickett asked if there would be a rendering of the new building to present to each company – no, still in preliminary stages.

Mayor Anlian stated the Board of Commissioners would like to know the outcome of the companies' votes within 30 days.
